Consultations update – summary table

The table (below) summarises the consultations we have responded to, and the consultations we are currently working on. It provides a forward look of expected or possible future consultations.

The information provided in the forward look has been obtained from a combination of sources including: media coverage, stakeholder engagement, references in other consultations, and intelligence gathered from Defra's consultation forward plan, DAERA's draft Environment Strategy and the England Environmental Improvement Plan (EIP) 2023. Some are speculative rather than definite. It is therefore not known for certain whether all of the listed items in the forward look will in fact be subject to public consultation. If they are not, we may still consider whether we want to provide advice on our own initiative (if it is a proposed change to environmental law brought forward by other means) or if we want to seek to be asked to provide advice.

Note on terminology

In the table above, forthcoming and potential consultations are classified as "expect to respond", "may respond", "unlikely to respond" and "to be assessed". The first three of these categories are used for consultations about which we have some reasonable indication of their possible content and can therefore make a judgement in principle about the importance of us providing some level of response:

- "Expect to respond" is used for consultations which have a significant alignment with priorities identified in the Corporate Plan.
- "May respond" relates to less significant consultations which may nevertheless be of sufficient value for us to respond to, subject to other factors such as resource implications.
- "Unlikely to respond" indicates those consultations which we consider to be unlikely to be of sufficient significance and value to merit an OEP response.

Note that we present these only as "in principle" judgements, rather than decisions at this stage. Any decision to respond to a consultation will be taken at the appropriate time, based on the strategic case for responding and consideration of how to make best use of the OEP's resources.

The table above also contains certain possible consultations about which little is currently known, some of which are also rather speculative as to whether they will happen at all. In

these cases, we have categorised the consultations as "to be assessed" where it would be premature to attach one of the more specific "in principle" judgements noted above.

Whilst many of the consultations outlined in table can be categorised under the OEP Business Priorities, this does not mean that we should prioritise responding to them. They will still be screened in line with the agreed consultation screening process.
